BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 20-0005 Series of 2020

WHEREAS, the OFFICE OF THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0548 re; Procurement of Desktop Computer, Netbook & Printers for use at the Office of the Provincial Social Welfare & Development, Tagbilaran City. with an ABC of P 112,086.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>B&J COMPUTER AND</u> <u>ELECTRONICS SERVICES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations:
