



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0426 re: Procurement of Engine Oil, Tires, Car Fresheners & Various Vehicle Spare Parts, by the Provincial Disaster Risk Reduction And Management Office, Tagbilaran City with an ABC of P 463,870.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES & SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of TAGBILARAN CITY TYRE SALES & SERVICE CENTER including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid TAGBILARAN CITY TYRE SALES & SERVICE CENTER has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


- a.) To declare TAGBILARAN CITY TYRE SALES & SERVICE CENTER as the bidder with the LOWEST CALCULATED AND RESPONSIVE BID for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2020-0307;
- b.) To recommend award to TAGBILARAN CITY TYRE SALES & SERVICE CENTER for the delivery of goods/services under Negotiated Canvass No. 2020-0307 in the amount of P 463,468.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


