- b.) To recommend award to B & J COMPUTER & ELECTRONICS SERVICES in the amount of ONE HUNDRED TWO THOUSAND SIX HUNDRED PESOS ONLY (P 102,600.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 074;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings


