

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL HUMAN RESOURCE MANAGEMENT & DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0636 re; Procurement of Plaques for PGBH Worker/Employee Awardees in line with the Celebration of 120th Philippine Civil Service Anniversary with an ABC of P 240,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CRISSANDER ENTERPRISES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
