

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. <u>20 -0579</u> Series of 2020

WHEREAS, the <u>PROVINCIAL TREASURER'S OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0414</u>; re; <u>Procurement of Diesel Fuel for use at Provincial Treasurer's Office, New Capitol Compound, Tagbilaran City.</u> with an ABC of <u>P 104,000.52</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BOHOL JL DISTRIBUTION</u> SYSTEM, INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>BOHOL JL DISTRIBUTION SYSTEM, INC.</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>BOHOL JL DISTRIBUTION SYSTEM, INC.</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to <u>BOHOL JL DISTRIBUTION SYSTEM, INC.</u> for the delivery of goods/services under Negotiated Canvass No. <u>2020-0297</u> in the amount of <u>P 103,867.19</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
