WHEREAS, the PROVINCIAL TREASURER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0414; re: Procurement of Diesel Fuel for use at Provincial Treasurer's Office, New Capitol Compound, Tagbilaran City. with an ABC of P 104,000.52;




