WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-0569 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **OFFICE OF THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT** in undertaking Procurement Request under PR No. 2020-0094 re: Procurement of Typewriter & Portable Wireless Amplifier for the use at the Office of the Provincial Social Welfare & Development, Tagbilaran City. with an ABC of ₱ 33,040.00;


