RESOLUTION NO. 26-6665 Series of 2020

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-0572 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL AGRICULTURIST in undertaking Procurement Request under PR No. 2020-0172 re: Procurement of Diesel Fuel for the Service Vehicle at Office of the Provincial Agriculturist New Capitol Site, Tagbilaran City. with an ABC of P 371,007.38.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BOHOL JL</u> <u>DISTRIBUTION SYSTEM, INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under <u>paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, BOHOL JL DISTRIBUTION SYSTEM, INC.</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;
