WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-0350 A series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL GENERAL SERVICES OFFICE in undertaking Procurement Request under PR No. 2020-0047 re: Procurement of Monobloc Chair for the use at the Provincial General Services Office, New Capitol Compound, Tagbilaran City. with an ABC of P745,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that OCCIDENTAL ENTERPRISES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
