WHEREAS, the CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL, LOON, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 143 re: PROCUREMENT OF DESKTOP COMPUTER & BIOMETRIC MACHINE with an ABC of P 300,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>B & J COMPUTER</u> AND ELECTRONICS SERVICES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid
