WHEREAS, the <u>PROVINCIAL BUDGET & MANAGEMENT OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0438</u>; 1e; <u>Procurement of Office Supplies for the use at Provincial Budget & Management Office</u>, New Capitol Compound, Tagbilaran City. with an ABC of <u>P 62,059.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>COPYLANDIA OFFICE</u>
