BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>PROVINCIAL ACCOUNTING OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0296</u> re; <u>Procurement of Various I.T Devices for use at Provincial Accounting Office</u>, <u>New Capitol Site</u>, <u>Tagbilaran City</u>, with an ABC of <u>P 282,072.00</u>.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>3 MSG ENTERPRISES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>3 MSG ENTERPRISES</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>3 MSG ENTERPRISES</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare 3 MSG ENTERPRISES as the bidder with the LOWEST CALCULATED AND RESPONSIVE BID for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2020-0197;
- b.) To recommend award to <u>3 MSG ENTERPRISES</u> for the delivery of goods/services under Negotiated Canvass No. <u>2020-0197</u> in the amount of <u>P 281,890.00</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
