WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. 2020-0604 re: Procurement of Toner, TK-6329 for Kyocera Multi Function Laser Copier for use by the Office of the Provincial Veterinarian, New Bohol Provincial Capitol Compound, Cogon District, Tagbilaran City with an ABC of P 72,800.00


WHEREAS, the above Procurement Request was presented to the **BIDS AND AWARDS COMMITTEE** for deliberation and proper action;


