WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST/ADMIN DIVISION of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0383; re; Procurement of I.T Equipment/Devices, Win10 Operating System & Internet Security for use at the Office of the Provincial Agriculturist/Admin Division, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City with an ABC of P 298,001.20;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that B&J COMPUTER AND ELECTRONICS SERVICES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;




