BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL ADMINISTRATOR'S OFFICE**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0591; re; Procurement of Various Office & Janitorial Supplies for use at the Provincial Administrator's Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City with an ABC of P 124,272.60;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **3 MSG ENTERPRISES** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **3 MSG ENTERPRISES** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **3 MSG ENTERPRISES** has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:
