WHEREAS, the PROVINCIAL MOTOR POOL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0670, re; Procurement of Core, Radiator for the KOMATSU Bulldozer BZ 106 at the Provincial Motorpool Office, New Capitol Building, Tagbilaran City with an ABC of P 350,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CARE AUTOHAUS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


