WHEREAS, the PROVINCIAL MOTOR POOL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0670; re; Procurement of Core, Radiator for the KOMATSU Bulldozer BZ 106 at the Provincial Motorpool Office, New Capitol Building, Tagbilaran City with an ABC of P 350,000.00;
