WHEREAS, the PROVINCIAL MOTOR POOL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0611; re; Procurement of Vehicle Spare Parts for the Mitsubishi & Komatsu Road Graders, by the Provincial Motor Pool Office, New Capitol Site, Tagbilaran City. with an ABC of P 395,472.00;
