WHEREAS, the OFFICE OF THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0514; re; Procurement of Engine Oil, Oil Filter, Fuel Filter, Chamois, Air Cleaner, Tires & Batteries for the Service Vehicle at the Office of the Provincial Social Welfare & Development, Tagbilaran City. with an ABC of P 80,100.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES & SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;




