



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **OFFICE OF THE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. 2020-0520, re; Procurement of Welcome Leis, Certificate Frames & Raffia Wooden Box for use at Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 321,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **ADS & PRINTS REPUBLIQ** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **ADS & PRINTS REPUBLIQ** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **ADS & PRINTS REPUBLIQ** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;


