WHEREAS, the OFFICE OF THE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0520, re; Procurement of Welcome Leis, Certificate Frames & Raffia Wooden Box for use at Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 321,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ADS & PRINTS REPUBLIQ offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
