TORIBIO MEMORIAL HOSPITAL</u>, <u>CARMEN</u>, <u>BOHOL</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. <u>- PHO – 2020 – 298</u> re: <u>PROVISION FOR THE REPLACEMENT OF PARTS OF COPIER INEO 185 & INEO 163</u> with an ABC of <u>P 58,027.00</u>;
