BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0182:re; Procurement of Inverter Type Air Conditioning Unit for the use at the Office of the Provincial Veterinarian Tagbilaran City. with an ABC of P 213,000.00:

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>SAMMY'S</u> <u>AIRCONDITIONING</u> & <u>REF. SERVICES AND REPAIR SHOP</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>SAMMY'S AIRCONDITIONING</u> & <u>REF. SERVICES AND REPAIR SHOP</u> ncluding the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>SAMMY'S AIRCONDITIONING</u> & <u>REF. SERVICES AND REPAIR SHOP</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to <u>SAMMY'S AIRCONDITIONING</u> & <u>REF. SERVICES AND REPAIR SHOP</u> for the delivery of goods/services under Negotiated Canvass No. <u>2020-0087</u> in the amount of <u>P 212,895.00</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
