



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PRES. CARLOS P. GARCIA MUNICIPAL HOSPITAL, PRES. GARCIA, BOHOL**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under **Purchase Requests No. - PHO - 2020 - 235** re: **PROCUREMENT OF RADIATOR COOLANT, BRAKE FLUID, ENGINE OIL, ARMOR ALL, TRANSMISSION OIL & VARIOUS VEHICLE SPARE PARTS FOR THE AMBULANCE** with an ABC of **P 223,980.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **200M AUTO REPAIR SHOP AND PARTS** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **200M AUTO REPAIR SHOP AND PARTS** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **200M AUTO REPAIR SHOP AND PARTS** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:


- a.) To declare **200M AUTO REPAIR SHOP AND PARTS** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount **P 217,625.00** for the **DELIVERY OF GOODS/SERVICES** under **Negotiated Canvass No. - PHO - 2020 - 176**;
- b.) To recommend award to **200M AUTO REPAIR SHOP AND PARTS** in the amount of **TWO HUNDRED SEVENTEEN THOUSAND SIX HUNDRED TWENTY FIVE PESOS ONLY (P 217,625.00)** for the delivery of goods under **Negotiated Canvass No. - PHO - 2020 - 176**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings




