



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL TREASURY OFFICE**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2020-0518**; re; **Procurement of Office Supplies for use at Provincial Treasury Office, New Capitol Compound, Tagbilaran City.** with an ABC of **P 109,046.64**;
