RESOLUTION NO. <u>20</u>–0736 Series of 2020

WHEREAS, the <u>PROVINCIAL HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE</u> of the <u>PROVINCIAL</u> GOVERNMENT OF BOHOL made procurement under <u>Purchase Request No. 2020-C-202 re: <u>PROVISION OF CATERING SERVICES DURING THE ORIENTATION OF THE NEWLY HIRED EMPLOYEES</u> with an ABC of <u>P 95, 000.00</u>;</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>PANDA TEA GARDEN</u> <u>SUITES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>PANDA TEA GARDEN SUITES</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>PANDA TEA GARDEN SUITES</u> has been found to be <u>ELIGIBLE</u> and its bid, <u>RESPONSIVE</u>;
