BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>PROVINCIAL MOTOR POOL OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. <u>2020-0585</u>, re; <u>Procurement of Grease</u>, <u>SAE Oil</u>, <u>Gear Oil</u>, <u>Brake Fluid and Coolant for use of Light and Heavy Equipment Assigned for the Road Development and Rehabilitation Project of the Government of <u>Bohol. Provincial Motor Pool Office</u>, <u>New Bohol Provincial Capitol Compound</u>, <u>Cogon District</u>, <u>Tagbilaran City</u> with an <u>ABC of P 523,550.00</u>;</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>GJ CAR CARE AND PARTS CENTER</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>GJ CAR CARE AND PARTS CENTER</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>GJ CAR CARE AND PARTS CENTER</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;
