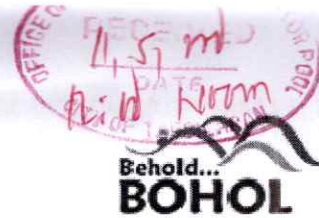

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL MOTOR POOL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0585; re; Procurement of Grease, SAE Oil, Gear Oil, Brake Fluid and Coolant for use of Light and Heavy Equipment Assigned for the Road Development and Rehabilitation Project of the Government of Bohol. Provincial Motor Pool Office, New Bohol Provincial Capitol Compound, Cogon District, Tagbilaran City with an ABC of P 523,550.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that GJ CAR CARE AND PARTS CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of GJ CAR CARE AND PARTS CENTER including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid GJ CAR CARE AND PARTS CENTER has been found to be ELIGIBLE and its bid, RESPONSIVE;
