WHEREAS, the GOVERNOR'S OFFICE - CD ART of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2019-C-194 re: PROVISION OF LUNCH AND SNACKS FOR THE VARIOUS ACTIVITIES OF THE COMMUNITY DEVELOPMENT PROGRAM with an ABC of P 549, 000.00;
