WHEREAS, the OFFICE OF THE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0470; re; Procurement of UV85+HP Handheld Radio for the use at the Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 51,000.00;
