## RESOLUTION NO. 20-0007 Series of 2020

WHEREAS, the BOHOL ENVIRONMENT MANAGEMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0687; re; Procurement of Rubber Boots and Reusable Rubber Gloves to ensure that each ESWM Personnel has a PPE while conducting Waste Management Activities of Bohol Environment Management Office, New Capitol Building, New Capitol Site, Tagbilaran City, Bohol. with an ABC of P 133,200.000;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 3 MSG ENTERPRISES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>3 MSG ENTERPRISES</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>3 MSG ENTERPRISES</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;
