



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the BOHOL ENVIRONMENT MANAGEMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0687; re; Procurement of Rubber Boots and Reusable Rubber Gloves to ensure that each ESWM Personnel has a PPE while conducting Waste Management Activities of Bohol Environment Management Office, New Capitol Building, New Capitol Site, Tagbilaran City, Bohol. with an ABC of P 133,200,000;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 3 MSG ENTERPRISES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:



- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.






