



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, THE OFFICE OF BOARD MEMBER ELPIDIO M. JALA, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0594; re: Procurement of Tubeless Tires Cleaning & Recharging of Freon, Oring, Compressor Oil at Silicon Oil by the Office of the Board Member Elpidio M. Jala, New Capitol Site, Tagbilaran City, with an ABC of P 71,150.00:

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES AND SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
