JALA, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0594; re; Procurement of Tubeless Tires Cleaning & Recharging of Freon, Oring, Compressor Oil at Silicon Oil by the Office of the Board Member Elpidio M.
