WHEREAS, the BOHOL TOURISM OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. C-2020-158-D; re; Provision of Live Telecast/Broadcasting Services for the Coverage of the Opening & Closing Ceremonies of the Philippine Travel Exchange 2020, by the Bohol Tourism Office, Tagbilaran City, Bohol with an ABC of P 250,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 136 ACTIVE EVENTS EQUIPMENT offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of 136 ACTIVE EVENTS EQUIPMENT including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid 136 ACTIVE EVENTS EQUIPMENT has been found to be ELIGIBLE and its bid, RESPONSIVE;

- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


