WHEREAS, the OFFICE OF THE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0743; re: Procurement for used during the different activities for the PGBh- CSO Week Celebration, by the Office of the Governor, New Capitol Compound, Tagbilaran City, with an ABC of P 120,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ADS & PRINTS REPUBLIQ offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;



- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




