



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the OFFICE OF THE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0425, re: Procurement of ATF Oil, Engine Oil, Gear Oil, Epoxy, Electrical Tape and Various Vehicle Spare Parts, Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 102,605.50;
