AGRICULTURIST} in undertaking Procurement Request under PR No. 2020-0024 re: CONSTRUCTION OF SHED HOUSE TO PROVIDE STORAGE WASHING & PACKING HOUSE TO THE BENEFICIARY FARMERS with an ABC of ₱ 300,000.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:


