

THIS AGREEMENT, made this 5<sup>th</sup> day of November, 2020 between Office of the Provincial Agriculturist of Provincial Government of Bohol (hereinafter called the "Entity") and INABANGA DRILLING CONSTRUCTION, STEEL FAB. & GENERAL MERCHANDISE of San Isidro, Inabanga, Bohol (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor **execute INABANGA DRILLING CONSTRUCTION, STEEL FAB. & GENERAL MERCHANDISE** of San Isidro, Inabanga, Bohol (hereinafter called "the Works") and the Entity has accepted the Bid for **P 599,426.00** in **Five Hundred Ninety Nine Thousand Four Hundred Twenty Six Pesos Only** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

WHEREAS, Project shall be completed in **60 Calendar Days** in accordance with the provisions of the Bid Documents;
