

WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0637; re; Procurement of Various Office Supplies For Office use at Office of the Provincial Veterinarian, New Capitol Compound, Tagbilaran City. with an ABC of P 163,635.50;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that GOLDEN AI TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


