

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>Provincial Disaster Risk Reduction Management Office</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0723</u> fe; <u>Procurement of Medicines for use at Provincial Disaster Risk Reduction Management Office, Tagbilaran City, Bohol.</u> with an ABC of <u>P 70,700.00</u>;
