

BAC Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2020-0788 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL GOVERNMENT OF BOHOL in undertaking Procurement Request under PR No. 2020-C-155 re: BULK PROCUREMENT OF CATERING SERVICES FOR THE DIFFERENT ACTIVITIES AND EVENTS OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR THE 3RD QUARTER OF CY 2020 – D. PACKED MEAL with an ABC of P 4, 411, 220.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. for item nos. 1, 2 & 3 and ALTA BOHOL GARDEN RESORT for item no. 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17 & 18 as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. and ALTA BOHOL GARDEN RESORT have been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. for item nos. 1, 2 & 3 and ALTA BOHOL GARDEN RESORT for item nos. 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17 & 18 as the supplier with the Lowest and Responsive Price Proposal for the Delivery of Catering Services under Negotiated Canvass No. 2020-163 (2nd Failure);
- b). To recommend award REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. in the total amount of P 1,154,776.00 and ALTA BOHOL GARDEN RESORT in the total amount of P 3,185,134.00 for the delivery of Catering Services under Negotiated Canvass No. 2020-163 (2nd Failure);
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings


