

A toss coin was made to break the tie declaring REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. the winner for the said item as reflected in the Abstract of Bid Proposals;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:




