WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2020-0733 series of 2020 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL GOVERNMENT OF BOHOL in undertaking Procurement Request under PR No. 2020-C-161 re: BULK PROCUREMENT OF CATERING AND ACCOMMODATION SERVICES FOR THE DIFFERENT ACTIVITIES AND EVENTS OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR THE 4<sup>th</sup> QUARTER OF CY 2020 – B. EVENTS/ ACTIVITIES/ PROGRAMS INVOLVING PROVINCIAL AND MUNICIPAL OFFICIALS, OTHER GOVERNMENT AGENCIES AND STAKEHOLDERS with an ABC of P 1, 357, 500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ALTA CEBU VILLAGE GARDEN RESORT, INC. for item nos. 1 & 2 and REYNA'S THE HAVEN RESORT, INC. for item no. 3, 4, 5, 6 & 7 as reflected in the Abstract of Bid Proposals;


WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC., and ALTA CEBU VILLAGE GARDEN RESORT, INC. have been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- b). To recommend award REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. in the total amount of P590,330.00 and ALTA CEBU VILLAGE GARDEN RESORT, INC. in the total amount of P762,250.00 for the delivery of **Catering and Accommodation Services** under Negotiated Canvass No. 2020-185 (2<sup>nd</sup> Failure);
- c). To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings


