

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL GENERAL SERVICES OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. 2020-0488; re: Procurement of Renovation & Improvement of Old DPWH Building (Phase 4), by the Provincial General Services Office, New Capitol Compound, Tagbilaran City. with an ABC of P 224,868.24;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **CLAIRE CONSRUCTION AND SUPPLY** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **CLAIRE CONSRUCTION AND SUPPLY** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **CLAIRE CONSRUCTION AND SUPPLY** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a.) To declare **CLAIRE CONSRUCTION AND SUPPLY** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE BID** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. 2020-0368;
- b.) To recommend award to **CLAIRE CONSRUCTION AND SUPPLY** for the delivery of goods/services under Negotiated Canvass No. 2020-0368 in the amount of P 224,539.80;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.




