WHEREAS, in the detailed evaluation of bids **3 MSG ENTERPRISES** was declared as the Single Calculated Bid as Read in the amount of P 2,730,975.00;

WHEREAS, Based on the Post Qualification conducted by the Technical Working Groups (TWG), **3 MSG ENTERPRISES** failed to pass for item nos. **1, 2, 3, 6 & 9** for the reason that their business institution that has no qualified manpower, technicians or certified repair shop who can cater electronics and electrical equipment problems specially Airconditioning Units & Generator Set;


WHEREAS, upon the conduct of post qualification by the Technical Working Group, **3 MSG ENTERPRISES** met the required legal, technical and financial requirements for the said project for item nos. **4, 5, 7, 8, 10, 11, 12, 13, 14, 15 & 16** ;

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **3 MSG ENTERPRISES** the bidder declared as the **SINGLE CALCULATED BID**, successfully passed the Post Qualification process for above mentioned items, thus the Committee now considered its bid as the **SINGLE CALCULATED and RESPONSIVE BID** for the said project;

NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:




