NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:



- b.) To recommend award to GOLDEN AI TRADING in the amount of FIFTY FOUR THOUSAND NINE HUNDRED NINETY FOUR PESOS ONLY (P 54,994.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 158;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings




