




WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 271 re: PROCUREMENT OF DISINFECTANT TABLE ( SODIUM DICHOROISOCYANURATE CHLORINE TABLET) ABC of P 261,900.00;
