NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:



- b.) To recommend award to AMEE'S OFFICE AND SCHOOL SUPPLIES in the amount of THREE HUNDRED FIFTY ONE THOUSAND SEVEN HUNDRED THIRTY FIVE PESOS ONLY (P351,735.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 265;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings




