



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL HUMAN RESOURCE MANAGEMENT & DEVELOPMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0602; re; Procurement of Gift Certificates (Goods) for the PGBh Worker/Employee Awardees in Line with the Celebration of the 120th Philippine Civil Service Anniversary, by the Provincial Human Resource Management & Development Office, New Capitol Compound, Tagbilaran City. NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


